Our Journey: With roots dating back to the founding of the first Cincinnati community development corporation in 1968, HomeBase has evolved into a catalyst for neighborhood revitalization. Our journey has been marked by a relentless pursuit of empowering communities through strategic planning, capacity building, and resident engagement.

A Paradigm Shift: In 2023, a transformation in Cincinnati's community development landscape began when HomeBase welcomed a team of dedicated, passionate individuals. In just four months, we spearheaded project management and consultant services for 18 neighborhood-based volunteer organizations, setting the stage for unprecedented community engagement and neighborhood planning.

Our progress is evident by the fact that the City of Cincinnati is looking to HomeBase to empower neighborhood CDCs & CBOs by managing SIX of their funding programs, just the past year pushing over \$5 Million into Cincinnati neighborhood revitalization. Most notably the recent addition of the City's \$1 Million "Quick Strike Acquisition and Project Support" approved by City Council, and an upcoming \$900,000 annual revolving fund that will impact every Cincinnati neighborhood.



Community Impact - Sedamsville Case Study: An embodiment of our commitment, Sedamsville, considered a neglected and traumatized neighborhood, HomeBase's efforts kindled the beginnings of community action, igniting conversations that's led to resident engagement and an on-going reimagining of the neighborhood's future. Beyond scooping ice cream, this event laid the foundation for community-led change, neighborhood activities, and the beginning of redevelopment efforts of the Klosterman Properties.

Programs that Drive Change: Fundraising need of \$500,000 HomeBase's internal programs stand as pillars of support for our communities. Our CDC Infrastructure Support, Training Reimbursement, Down Payment Assistance Program, and Neighborhood Growth Fund are critical avenues through which we empower CDCs and facilitate substantial, lasting change.



What are CDCs?

What is Community Development?

Community Development Corporations

Community development corporations (CDCs) are 501(c)(3) non-profit organizations that are created to support and revitalize communities, especially those that are impoverished or struggling.

Community Housing Development Organization (CHDO) A CHDO is a type of CDC that is a private nonprofit, community-based organization that has staff with the capacity to develop affordable housing for the community it serves.

CDCs often deal with the development of affordable housing. They can also be involved in a wide range of community services that meet local needs such as education, job training, healthcare, commercial development, and other social programs.

We also support other **Community Based Organizations (CBOs)** that are not formal CDCs.

What is Community Development?

Per U.S. Department of Housing and Urban Development (HUD): Community development activities build stronger and more resilient communities.

In order to be eligible for (HUD) funding, CDC activity must qualify as meeting one of the three national objectives of HUD's Community Development Block Grant (CDBG):

- 1. Benefiting low- and moderate-income persons,
- 2. Preventing or eliminating slums or blight, or
- 3. Meeting other community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community and other financial resources are not available to meet such needs.

How We Help Communities Thrive: HomeBase Funding Programs



CDC Infrastructure Support (BackOffice Grants): Fundraising need \$100,000

Members agree to pay the full cost of the vendor and are reimbursed from HomeBase, up to a maximum amount of \$4,000.00 as the grant funds are available. CDC's must have a valid contract with HomeBase to be eligible for the grant money.



Training Reimbursement: Fundraising need \$100,000

We provide reimbursements for the costs of professional training for members' staff, whether conducting training internally or referring & reimbursing outside sources for learning. CDC staff members have gone through the ULI Real Program, NACEDA trainings, and more.



Down Payment Assistance Program: Fundraising need \$100,000

The HomeBase Down Payment Assistance Program (DAP), funded by Greater Cincinnati Foundation, was created to distribute approximately \$100,000 of down payment assistance funds in \$5,000 increments. It is designed to support the efforts of member CDCs to increase sales and support eligible families.



Neighborhood Growth Fund: Fundraising need \$200,000

The Neighborhood Growth Fund is a capacity-building tool for Cincinnati's emerging neighborhoods. This fund allows communities to comprehensively revitalize neighborhoods in these areas: Workforce Development, Neighborhood Business Development, Placemaking, Health, Economic Development, Education, Safety, Housing, & Civic Engagement.



Our Pass-through Funding Services from the City of Cincinnati

The **Neighborhood Business District Support Grant (NBDSG)** program was created in response to the COVID-19 pandemic to aid small businesses, enhance outdoor spaces or improve the built environment. (ARPA funds)



The **Community Development Block Grant (CDBG)** is a competitive funding source made available through the City of Cincinnati Department of Community and Economic Development to provide Community Development Corporations with operating support grants and project support. (HUD funds)

The **Voluntary Tax Incentive Contribution Agreement (VTICA)** program contributes 15% of the value of a development tax incentive back to affordable housing and neighborhood quality of life projects outside of downtown and Over-the-Rhine.

2022-2023: Service & Program Impact

Driving Measurable Results

Neighborhood Business District Support Grants (City of Cincinnati)

HomeBase disbursed over \$2.5 Million in onetime NBDSG funding funds to 41 small business through 18 neighborhoods, majority of which are in Roselawn, and 14 nonprofits in the City of Cincinnati:

- → 4 Minority Businesses supported
- → 7 Women Businesses
- → At least 20% of funding went to Tenant Improvement projects

Operating Support Grant (City of Cincinnati)

HomeBase disbursed \$593,479 in Operating Support Grants (OSG) to 12 CDCs that supplemented wages for total of ~110 staff persons. Awards ranged: \$15,000 to \$67,500

Operating Support Grant Total Project Leverage: \$35,775,153 Leverage Ratio 60.28

Private Project Dollars \$2,512,719 Tax Credits Allocated \$18,864,931 Public Project Dollars \$6,740,585 Operational Dollars \$7,656,917

Community Development Block Grants (City of Cincinnati)

HomeBase disbursed \$500,000 in CDBG project support to 12 CDCs, which is currently wrapping up and will be reported on in early 2024.

HomeBase staff leveraged and project managed \$400,000 in CDBG that has supported an additional 18 CDC's or CBOs in 15 different neighborhoods.

Thanks to this funding, HomeBase's team was able to activate:

- → Community engagement activation and projects in 2 neighborhoods
- → Website and marketing support in 3 neighborhoods
- → Housing & Market studies in 3 neighborhoods
- → Community plan and alignment consultants, NBD planning, or other project support for 8 neighborhood organizations
- → Pedestrian safety and urban design consultants in 2 neighborhoods

CDC Infrastructure Grants (HomeBase & PNC Foundation)

HomeBase disbursed just over \$8,000 in CDC Infrastructure (back-office expenses) grants to 4 CDCs thanks to a grant from PNC Foundation. These small grants cover legal, audit, and other operating expenses not covered elsewhere. However, the expressed need equaled to \$51,000 from just 7 CDCs.



Our Community Development Members and Cincinnati's CDC Ecosystem

HomeBase recognizes and supports the diversity of our City's neighborhoods and the community development ecosystem. No two neighborhoods, nor CDC's look exactly alike, but are oftentimes involved in similar activities across a spectrum of community development efforts and capacities.



Some community based organizations might be volunteers only and not involved in the real estate development aspects of their community yet, but are laying the foundation to do so by creating a comprehensive neighborhood plan. Other CDC's have been building on their community plan for decades- revisiting and tweaking the plan to match the flux and needs of its residents, with development based revenue streams and paid staff.

HomeBase supports the neighborhood based community development continuum however we are needed- whether a startup community based organization, or a formal CDC reflecting the definitions by HUD and the National Alliance of Community Economic Development Association (NACEDA).

Community Impact Case Study:

Reviving Sedamsville— Community Growth, Partnership and Celebration



Sedamsville is considered to be a blighted, "left behind" neighborhood in the City, and is also home to mainly low to moderate income folks with few resources. This summer, HomeBase connected with neighborhood leaders who are interested in improving the quality of life for their fellow residents.

The Sedamsville Civic Association (SCA) requested just \$200 from HomeBase to host an event to catalyze resident engagement with the association's members, but more importantly to begin conversations reimagining the future of the neighborhood. HomeBase co-hosted an ice cream social in Bold Face Park, attracting residents to engage with the civic association and to physically interact with the park and the renovations occurring there.

HomeBase and the five civic association members worked together to staff and manage the event and engage with residents to discuss what they need from, and what changes they would like to see, in their community. Over three-hours, about 50 residents stopped by, meeting the SCA members, and learning how they can be involved with future community-based events.

Besides scooping free ice cream cones to the kiddos and adults of Sedamsville, this event was a major first step toward cultivating and achieving resident buy-in and engagement for future community-led change and improvement.



Additionally, open ended questions on post-card sized, anonymous, "listening cards" were given to residents to fill out. The questions included;

What has been your experience as a Sedamsville resident? What do you like/dislike the most about living here? What changes do you think would improve the neighborhood? What can the SCA do to encourage your attendance at meetings and to improve communication?

Giving residents a space to "reimagine" Sedamsville comes at a crucial moment in time for the community as Sedamsville has quite a bit of focus on it from the City of Cincinnati



and Hamilton County. In 2020, The Port of Cincinnati and the Land Bank acquired the "Klosterman Properties," a set of 42 rental properties and a vacant church, that were under the control of a terrible slum lord for decades who was the source of heinous trauma to many women and people.



HomeBase is providing the project management and funding for a housing / redevelopment study for these properties. Sedamsville's neighborhood development plan is 20 years old, and new community strategic plans require, and need, considerable amount of community engagement and buy in to make progress happen.

These first steps toward major community change are beginning to snowball as the Civic

Association has since hosted a community trunk or treat and has plans for a winter community engagement with local police and fire fighters.

Empowered, Sedamsville is making its collective voice known regarding the need for more frequent Metro services for residents to access fresh food up the hill in Price Hill, as well as other future thinking needs and wants to benefit the community.



HomeBase Today and the Future

HomeBase is on the precipice of expanding our impact even further and aims to be a

nationally recognized model for community revitalization. In May 2023, after 40 plus years, a fundamental paradigm shift began in Cincinnati's community development ecosystem when the new HomeBase team of devoted, passionate, go-getters came on board.

In just 4 months, the team took on project managing and acquiring consultant services for 16 neighborhood-based volunteer organizations to begin development capacity building, activate community engagement, and begin strategic neighborhood planning. This is in addition to the 18 CDC organizations HomeBase has regularly supported in the past.



HomeBase staff and three UC DAAP Co-Ops

The City of Cincinnati is focused on HomeBase being the primary convenor, advocate, growth accelerator, subject matter expert, capacity builder, and funder for our member CDCs across the City.

The less time CDCs spend worrying about fundraising and connecting the dots, the more time and funding they can give back to our communities. We are helping our CDCs be savvier and more efficient community developers. We collaborate with, and are a connector for, trusted and experienced community development organizations.


